In South Africa, upon a person's death, the first step is to call paramedics or a medical professional for legal certification. Following this, contact undertakers like Centurion Funeral Directors.



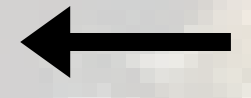
Registration of Death

The death must be registered with the Department of Home Affairs. This is essential to obtain the death certificate, which is a legal requirement before funeral arrangements can proceed.
